Section 4. First Aid Measures

IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Gently wash with plenty of soap and water. Rub calcium gluconate gel immediately to skin. Obtain medical assistance. Wash contaminated clothing before reuse.

Section 5. Fire Fighting Measures

Fire & Explosion hazards: While nitric acid is not combustible, it is a strong oxidizing agent that can react with combustible materials; however, it is present in limited quantities in this solution. NO_x compounds can be released in case of fire.

Extinguishing Media: Use any extinguishing media that is suitable for the surrounding area. Use a water spray to dilute nitric acid and to absorb liberated nitrogen oxides.

Specific Methods: Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

Section 6. Accidental Release Measures

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Do not allow to enter drainage systems or water ways. Dike area and dilute spill with water and neutralize with soda ash, limestone, etc. Place the neutralized material into containers suitable for eventual disposal, reclamation, or destruction. Section 7. Handling and Storage

This solution contains natural radioactive thorium oxide and uranium oxide at <0.001% concentration. Both are weakly radioactive and emits alpha particles which are harmful to the body. For the energy range of alpha particles usually encountered, a fraction of a millimeter of any ordinary material is sufficient for absorbance. Thin rubber, acrylic, stout paper, or cardboard will suffice.
